

Cross-Border and International Practicums

(Revised 11/01/2024)

The MACP program is aware of challenges that students may face in locating a practicum site and site supervisor, including students who live outside of Canada in being able to complete the practicum requirements. Therefore, the MACP Department of Field Training has created the following policy and viability checklist in order to help students who reside within and outside of Canada achieve a greater potential for success in completing their practicum experience.

The MACP student who resides outside of Canada must adhere to all stated requirements for acquiring a practicum site (appropriate practicum setting), site supervisor (meet site supervisor requirements), practicum hours requirements, individual supervision requirements and completion of all practicum course requirements as discussed in the MACP Student Practicum Manual. Students who reside outside of Canada must also consider the following additional requirements for Practicum:

Professional Liability Insurance

Yorkville University does not provide liability insurance coverage for students completing a practicum placement outside of Canada. The MACP student will be required to obtain their own professional liability insurance for the duration of practicum. It will be important for the student to speak with the potential site about any additional insurance coverage required by the site.

Online Zoom Meetings

Meetings held online in Zoom are a mandatory part of the practicum course graded components and the student must ensure that he/she/they/them have reliable access to Zoom from the country in which they/them desire to complete their practicum placement.

Language

At least 50% of client's sessions must be in English, and the supervisor must be able to communicate in English with Yorkville University staff and faculty as these individuals will be part of the student's practicum learning and support team.

Viability Checklist

The MACP student who desires to complete their Practicum outside of the location within which they reside, or student who resides outside of Canada, is required to provides written responses to a viability checklist questionnaire. The questionnaire is linked below. The student's responses will be reviewed by the MACP Associate Director of Field Training and determination will be made as to the viability of the proposed practicum placement.



Cross-Province and International Practicum Placement Policy

Before identifying an international practicum site and supervisor, students are solely responsible:

To find out about their province, territory, or country's opinion or declaratory statement issued by the relevant regulatory bodies and/or other practitioner licensing boards that may help inform the student of the legal and regulatory requirements involved when practicing counselling and/or psychotherapy services across jurisdictions and/or across borders in different countries.

To find out about their province, territory, state, or country's potential residency requirements pertaining to the actual physical location of practicum sites, i.e., client-location.

To find out about their province, territory, state licensure board, or country's potential supervisor requirements and what professionals are qualified to serve as supervisors.

To find out about their province, territory, state, or country's requirements regarding specific qualifications that need to be met if the practicum is to be accepted for licensure, registration, or certification purposes.

The MACP Program encourages international students to solicit a formalized agreement from their prospective practicum site situated beyond the borders of Canada. This agreement should comprehensively delineate various aspects relating to how supervision will be carried out, provide clear information about any potential fees or costs, and provide additional details or explanations about any relevant aspects pertinent to the practicum placement.

In addition to the standard practicum application process, students looking to complete a practicum in a province different than where they reside and/or at an international site are required to provide complete written responses to the following cross-border and/or international practicum questions and submit this document directly with their practicum application documents. Written response can also be sent to the Department of Field Training for review and approval. The Associate Director of Field Training will contact the student with their determination.

Affiliation Agreement

Some practicum sites, in particular hospitals, school boards, and government departments require an affiliation agreement, which is a contract between the practicum site and the University. If the potential organization (site) does require YU to agree to and sign an Affiliation Agreement, please be advised that for an affiliation agreement to be put into place, the process usually involves several officials within the practicum organization and the University to negotiate and sign an Affiliation Agreement. This process often can take months.

Practicum Supervisor
Please review the <u>Student Manual Addendum-Site Supervisor Requirements</u> , <u>effective January 1, 2022</u> , posted on the MACP Practicum Portal-Students' website. All site supervisors must meet the site supervisor requirements, no matter where the supervisor resides/practices, in order to be considered for approval as a site supervisor for MACP practicum students.
Additionally, the proposed site supervisor, onsite and/or external, is responsible for:
Providing the Required Onsite Supervision roles and responsibilities as outlined in the MACP Student Practicum Manual.
Provide individual supervision each week for no less than 60 minutes.
Meet in a scheduled Zoom conference call with the Practicum Faculty Instructor and student near the each of each trimester of practicum to engage in a Faculty Instructor Evaluation meeting to discuss the student's progress in practicum.
Access the MACP online platform for reviewing and approving the practicum student's hours logs throughout the practicum experience.

Will the site supervisor be able to provide direct observation of you counselling clients at a minimum of ten hours during the practicum experience?
Language Requirement
Yorkville University offers it programs in the English language and faculty must be able to evaluate student's counselling competencies in the English language. For students who will be completing a practicum at a site where English is not the first language.
Please answer the following questions:
Is the site supervisor able to speak English to provide feedback for the faculty instructor's evaluation of the student?
Will at least 50% of the counselling sessions conducted by the student be in the English language?
Will the student be able to record counselling sessions to complete the Student Video Case Presentation practicum course assignment in the English language, with both the
student and client speaking English?



Home and/or Off-site Client Visits

It is the expectation of the university that students will see clients at their practicum site or via tele-mental health counselling, and not in other locations not approved by the University. Offering counselling services off-site must be an exception and not a regular part of the student's practicum experience.

Accessing Zoom Outside of Canada
Online meetings for PSYC7113 and PSYC7203 are conducted through a meeting software called Zoom that has been provisioned by the University for all staff, faculty and students to use where needed. Students preparing for practicum are responsible for ensuring they can access Zoom from the country in which they choose to do their placement, as online Zoom meetings are a mandatory part of the PSYC7113 and PSYC7203 Practicum course.

Tele-mental Health Counselling

Tele-mental health counselling is now an acceptable and approved delivery model for students to engage their clients. The site is responsible to make sure students have all they need to be successful when engaged in tele-mental health counselling with clients, which includes but is not limited to training, appropriate technology, supervision, and client and student safety.

The practice of tele-mental health counselling and psychotherapy services requires careful consideration of legal requirements, ethical standards, telecommunication technologies, intra- and interagency policies, and other potential constraints and demands. It will be important for MACP students to be cognizant and compliant with laws and regulations that govern counselling and psychotherapy practice within jurisdictions and across jurisdictional and international borders. Canadian organizations such as CRPO, CPA and the CCPA have created guidelines to inform agencies and clinicians of the provision of psychological services using electronic media.

Research the website most applicable to you for published guidelines, standards, rules, and laws, for engaging in the practice of counselling via tele-mental health counselling.

Students living in Other Countries:
What are the guidelines for providing tele-mental health counselling when you reside in a country different than the country where your clients reside?
Insurance
Yorkville University insurance does not provide liability insurance coverage for students completing a practicum placement outside of Canada. Yorkville University MACP students will be required to obtain their own professional liability insurance for the duration of practicum. It will be important to speak with potential site supervisors about any additional insurance coverage required by the site.
